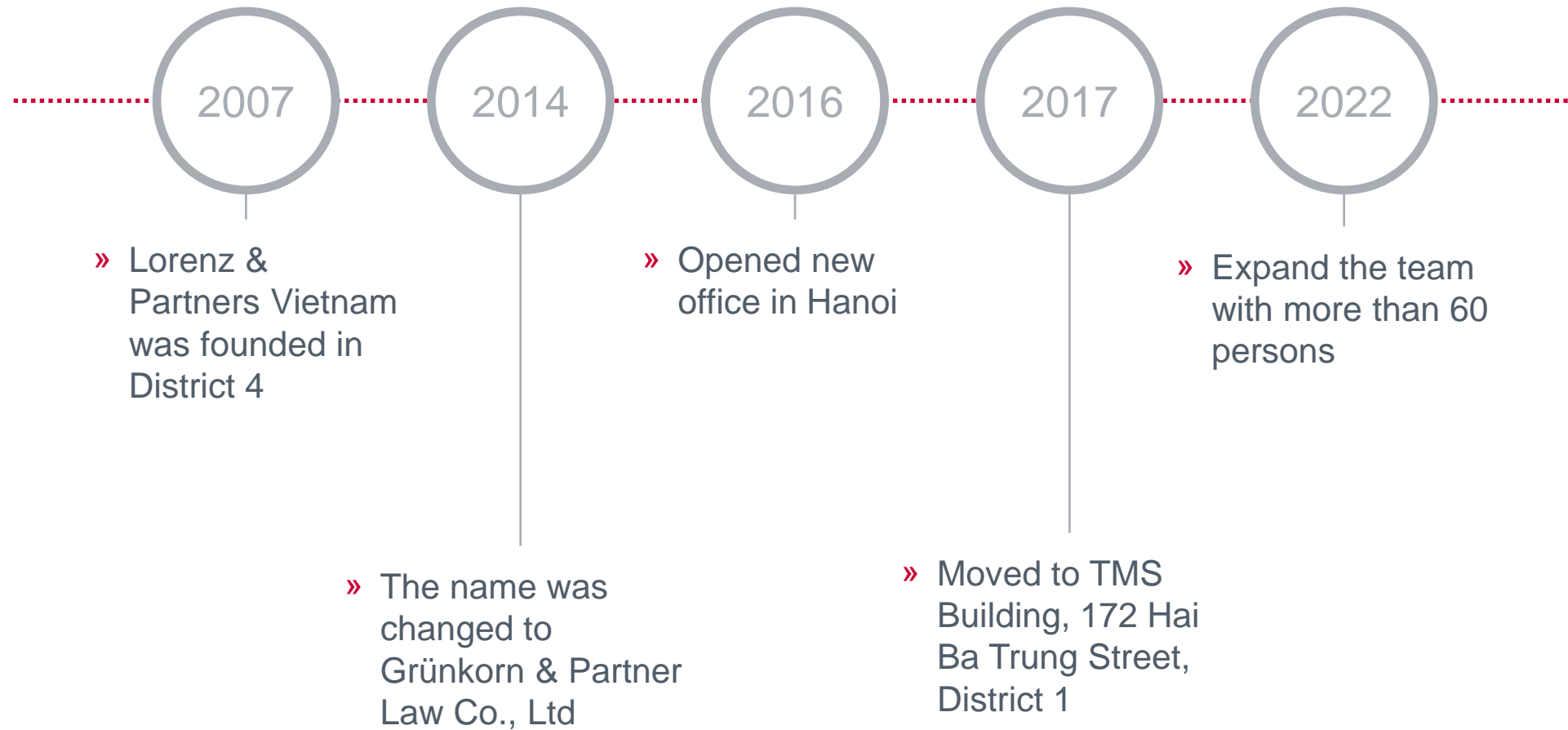

Providing above services without license is not legal

- » We are proud that WTS Tax Vietnam Co., Ltd. received the Accounting license from the Ministry of Finance (MOF). Currently only 145 companies are licensed for this service in Vietnam, WTS holding the No. 70. Only very few companies having a foreign background are having this license. The license as Tax Agent was issued by the General Department of Taxation at the MOF (GDT) and is registered under the No. 301. Besides these, only the Auditing Firms are allowed to provide these services. Our employees all hold the relevant personal licenses.
- » We are aware that several service providers offer these services without being licensed. Engaging them will bring considerable risks to the corporation and the persons in charge of compliance. It is highly suggested to check for these licenses before agreeing on a related service. The issued licenses are listed on the government websites of MOF and GDT:
